-- The Fiber Arts Market at the Sequim Open Aire Market is on the street and in front of the Museum & Arts Center. The address is 175 W. Cedar Street, Sequim, WA 98382.

-- The Fiber Arts Market will be open for setup from 7:00 to 9:00 AM on Saturday.

-- It will be open for business 9:00 AM – 3:00 PM.

-- The breakdown is 3:01 to 5:00 PM.

-- 10' x 10' spaces are available at \$30.

-- You will have to provide your own canopy, tables, and chairs for outside. Please bring table coverings, no linens are supplied.

-- Each vendor is required to do their own cleanup. We need to leave our spaces as clean as we found them, "leave no trace".

-- Vendor applications will be processed as received; due to limited space, preference is being given to most directly appropriate wares. You will be notified soon as possible or before August.

In the event NOFAF and MAC is named as defendant in any action covered by this indemnification and hold harmless agreement, then in such an event, the undersigned vendor does hereby agree to immediately accept the tender of said defense, defend said action, and hold NOFAF harmless of any liabilities thereon.

I understand that the vendor space must be open during Fiber Arts Market hours.

This form must be signed and returned to the vendor coordinator before entry to the Festival. Failure to do so will result in forfeiture of space and fees.

This agreement is not valid until approved by a representative of the NOFAF 2012.
