### Call for Vendors

In 2008, two venues are available to vendors: 3-day indoor vending at the Dungeness Schoolhouse, Friday October 3<sup>rd</sup> through Sunday October 5<sup>th</sup>; and one-day with activities or fiber animals, outdoors, at the Farmer's Market, Saturday October 4<sup>th</sup>.

We'd like a similarly diverse variety of vendors – fibers, supplies, tools, and books for felting and spinning; handspun and hand-dyed yarns for weaving, knitting, and knotting; and other materials that coordinate with the workshops. The workshops noted with asterisks and days are expected to be at Dungeness Schoolhouse, on the days noted. There will be a fiber art fashion show at the Dungeness Schoolhouse, beginning at 5 p.m. Saturday evening. Additional workshop locations include: A Dropped Stitch, Sue Nylander's studio, and the Museum Archives Building. The workshop list is not final yet! It will be finalized in June.

There is no fee to festival attendees to visit the vendor hall – thus you may see both workshop and general traffic. The Dungeness Schoolhouse is about 5 miles from the center of Sequim. The North Olympic Fiber Arts Festival is advertised on the internet, at Washington and Oregon fiber festivals, and in local papers.

### **Friday-to-Sunday Indoor Vending Details (Oct. 3, 4, 5)**

The Vendor's Hall will be in the downstairs room of the Dungeness Schoolhouse. There are stairs and ramp entrances to the building. The address is 2781 Towne Rd (at Marine Drive), Sequim, WA 98362.

The Vendor's Hall will be open for setup from 8 am to 10 am each day, and for wrap-up 6-6:30 Friday, 5-5:30 Saturday, and for breakdown from 6pm to 7:30 pm Sunday . It will be open for business 10 am – 6 pm Friday, 10 am – 5 pm Saturday, and 10 am – 6 pm Sunday. The room will be locked at close of business daily and unlocked at 8 am.

Each vendor will have one space, we have two 8 x 12 spaces at \$60 each and five 8 x 8 spaces at \$50 each available. Teachers receive a \$20 booth discount!

Table and chairs are provided, please note on your application if you do not want them for your booth. Please bring table coverings, no linens are supplied. Overnight coverings are recommended as well.

Vendor applications will be processed as received; due to limited space, preference is being given to local vendors with the most directly appropriate wares. Applications will be accepted starting May 26<sup>th</sup>, and initial applicants will be notified by June 30<sup>th</sup>.

Enclose a check for the booth made payable to North Olympic Shuttle & Spindle Guild, and a signed Hold Harmless Agreement. Business Insurance is highly recommended.

### **Saturday Outdoor Vending Details (Oct. 4)**

In conjunction with the weekend farmer's market, on Saturday there will be outdoor spaces available for vendors with interactive booths – a fiber activity for attendees to do at the booth, or a pettable fiber animal. Past activities have included: felting a bookmark, learning drop spindling, and more. Details on the number and type of fiber animal need to be provided with your vendor application, as we must provide accurate information to the city. Angora rabbits, fiber dogs, and larger are acceptable. The animals must be pettable by market attendees. Each vendor is required to provide their own cleanup. We need to leave our booth spaces as clean as we found them, "leave no trace".

Weather can be risky, so please come prepared. Wind, rain, cool temperatures are possible, as is a delightful sunny day – umbrellas and sunscreen could both be needed!

Outdoor vendors must provide their own canopy, table and chairs. They must also bring 30-pound weights for each corner of their canopy – sand-filled milkjugs or cinder blocks are typically used by the street vendors. A canopy with sides is recommended.

Each vendor will have one space, we have three 8 x 8 spaces available. The vendor fee for Saturday outdoor vending is \$20. Teachers receive a \$10 space discount!

Vendor applications will be processed as received; due to limited space, preference is being given to local vendors with the most directly appropriate merchandise. Applications will be accepted starting May 26<sup>th</sup>, and initial applicants will be notified by June 30<sup>th</sup>.

Enclose a check for the booth made payable to North Olympic Shuttle & Spindle Guild, and a signed Hold Harmless Agreement. Business Insurance is highly recommended.
